- 316. SHRI R. T. GOPALAN: Will the Minister of RAILWAYS be pleased to state:
- (a) whether Government have formulated any scheme to make Railway Protection Force more effective in view of constant increase in the cases of thefts, robbery and murders; and
 - (b) if so, the details thereof?

THE MINISTER OF STATE IN THE RAILWAYS MINISTRY OF (SHRI MALLIKARJUN): (a) and (b) Policing being a State subject, maintenance of law and order and control of related crime on railway premises including running trains is the responsibility of the State Governments which they discharge through their respective Government Railway Police. As regards the Railway Protection Force which is intended for the security and protection of railway property, various measures are being taken from time to time to modernise the force and to make it more efficient by equipping it with modern equipments, vehicles, arms and ammunition and training aids,

Memorandum from all India Loco Running Staff Association, New Delhi

(b) and (c) The memorandum demands reinstatement of dismissed loco running staff and for implementation of various judgments of the Central Administrative Tribunals in that regard. 294 staff have already been reinstated as a result of Court orders. 349 staff remain dismissed/removed. Government have decided not to reinstate them. However, court cases filed by some of the 349 staff involve important questions of law and these cases are pending in Supreme Court.
