Statement

The findings of the Audience Survey on telecast of Question Hour in Parliament.

- More than four-fifth respondents at all India level were aware of the telecast of Parliamentary telecasts.
- Three-fourth respondents claimed to watch Parliamentary telecasts atleast once during the week.
- There were almost equal number of regular/frequent and occasional viewers of Parliamentary telecasts at all India level 23 per cent to 28 per cent. Little less than 20 per cent said, they never watched' these telecasts.
- Maximum number of regular/frequent viewers of the telecasts were in north—60 per cent to 80 per cent, followed by in east 40 per cent to 65 per cent.
- The main reason forwarded for not watching these telecasts were: 'inconvenient telecast time', 'not interested in such programmes' or 'out of home'.
- 41 per cent at all India level claimed to watch the telecast of Parliamentary proceeding yesterday. The maximum audience share was in North, (51% 71), followed by East (30 52), West (18 -40) and South (12 -45).

- 38% at all India level found the Parliamentary telecast 'interesting', 52% said, 'Satisfactory' and 10% maintained 'not at all interesting'.
- Around three-fourth respondents at all India level were in favour of the continuation of Parliamentary telecasts
