

the production of Pulses and oilseeds in the country. Public Distribution System has been revamped and extended to far-flung, remote and hilly areas to help the poorer sections of the society in getting essential items at reasonable prices. For this purpose, 1700 blocks have been selected under the revamped DPS programme. The Government have intensified the action under the Essential Commodities Act, 1955 against hoarders, black-marketers and such antisocial elements. During the period 1-1-1992 to 30-3-1992 as many as 17033 raids were made, 521 persons arrested, 955 persons prosecuted, 24 persons convicted and goods worth Rs. 142.81 lakhs has been confiscated. As a result of various measures taken by the Government, there has been a decline in the prices of essential commodities such as Pulses, Potatoes, Onions, Chillies, Tea, Gur, Mustard oil, Groundnut oil and Vanaspati. The price of sugar has also stabilised at most of the centres.

Drive against hoarders

Will the PRIME MINISTER be pleased to state:

(a) whether Delhi Administration has taken any steps recently to check godowns to check hoarding of rice/wheat;

(b) if so, the details thereof including the number of traders arrested by the team;

(c) whether the steps to unearth hidden stocks is continuing till date; and

(d) if so, what are the details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF CIVIL SUPPLIES, CONSUMER AFFAIRS AND PUBLIC DISTRIBUTION (SHRI KAMALUDDIN AHMED): (a) Yes, Sir

(b) Since January, 1992, Food, Supplies and Consumer Affairs Department of Delhi Administration checked the business premises of 24 rice and wheat traders. FIRs were lodged against eight traders; four persons were arrested. Irregularities committed include non-maintenance of correct accounts of sales¹/ purchases and or holding stocks in excess of those prescribed during raids and checkings.

(c) and (d) The checking of licences issued under various Control orders issued by the Food Supplies and Consumer* affairs Department of Delhi Administration is an ongoing process. Raids/surprise checkings are conducted by the Department from time to time. A control Room is functioning for receiving complaints from the public. An anti-hoarding cell is also attached to the Department for gathering information and rendering assistance during raids and checkings.

High prices of foodgrains far the open Market
