## WRITTEN ANSWERS TO STARRED AND UNSTARRED QUESTIONS

### 3G spectrum bids

\*141. SHRI VIJAY JAWAHARLAL DARDA:  
SHRI GIREESH KUMAR SANGHI:

Will the Minister of COMMUNICATIONS AND INFORMATION TECHNOLOGY be pleased to state:

- (a) whether his Ministry has delayed 3G spectrum bids considerably;
- (b) if so, whether the Ministry of Finance has also urged his Ministry to hold auction as early as possible so that the estimated Rs. 40,000 crores can be budgeted in the current fiscal books to bridge the fiscal deficit;
- (c) if so, whether a number of political parties have also criticised Government over the favouring of chosen corporates;
- (d) if so, whether the new 3G telecom is to share a 3 per cent revenue with Government; and
- (e) if so, by what time a final decision in this regard is likely to be taken?

THE MINISTER OF COMMUNICATIONS AND INFORMATION TECHNOLOGY (SHRI A. RAJA) : (a)  
No, Sir.

(b) The Government has announced detailed guidelines for auction and allotment of spectrum for 3G telecom services on 1st August, 2008 and certain amendments on 11st September, 2008. As per the guidelines, any person (i) who holds a UAS/CMTS licence: of (ii) (a) who has previous experience of running 3G telecom Services: and (b) gives an undertaking to obtain Unified Access Services Licence (UASL) as per Department of Telecommunications guidelines dated 14.12.2005 before starting telecom operations, can bid for 3G spectrum. The Ministry of Finance has desired that the auction of 3G Spectrum be conducted by January, 2009 and the full amount deposited in the exchequer by February, 2009. The amount which would be realized from the auction shall e known only after the auction process is complete.

(c) No, Sir.

(d) and (e) The proposal to levy annual spectrum charges for stand alone 3G operators will be finalized shortly.

#### **Scheme for urban transport planning**

\*142. SHRI GIREESH KUMAR SANGHI:  
DR. T. SUBBARAMI REDDY:

Will the Minister of URBAN DEVELOPMENT be pleased to state:

(a) whether Government is likely to launch a Rs. 152 crore scheme for urban transport planning to encourage states to upgrade public transport systems which are crumbling in most cities including the Metros;

(b) if so, whether his Ministry's programme that is aimed at promoting eco-friendly, safe, comfortable and affordable public transport would push cities to take up studies to prepare detailed project reports after comprehensive and thorough evaluation of alternate technologies;

(c) if so, whether his Ministry has already started studies in this regard; and

(d) if so, by what time a final decision in this regard is likely to be taken?

THE MINISTER OF URBAN DEVELOPMENT (SHRI S. JAIPAL REDDY) : (a) to (d) A new centrally sponsored scheme of Urban Transport Planning has been launched by the Government from August, 2008 to provide central financial assistance to States/Urban Local Bodies, (ULBs) upto 80% total cost for taking up various traffic and transportation studies etc. and upto 50% of the total cost for preparation of Detailed Project Reports (DPRs). The estimated cost of the scheme during the Eleventh Five Year Plan including State/Urban Local Bodies share is Rs. 124.70 crore. The Scheme covers a wide gamut of urban transport planning matters for promoting comprehensive urban mobility plan integrating land-use and transport, preparation of Detailed Projects Reports (DPRs), Clean Development Mechanism (CDM) studies, Intelligent Transport System (ITS) studies, launching of awareness campaign etc. in line with the National
