

### **Increasing activities of naxalites in Northern States**

†1001. SHRI PRABHAT JHA: Will the Minister of HOME AFFAIRS be pleased to state:

(a) whether it is a fact that the naxalites are increasing their activities in Northern States of the country;

(b) whether it is also a fact that many defence personnels and armed force personnels have been killed in naxalite attacks during the last one year;

(c) if so, the State-wise details thereof; and

(d) the details of the steps being taken by Government to curb the naxalite activities from spreading to other States?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI SHRIPRAKASH JAISWAL): (a) to (d) Naxals are trying to expand their activities to northern States like Haryana, Delhi, Himachal Pradesh, Uttarakhand, Punjab etc. No instance of naxal violence has been reported from these States during last one year. Also, no casualty of defence personnel and armed forces personnel have been reported.

State Governments take necessary steps to curb naxal activities within the States. Spread to other States is tackled through inter-State security and operational coordination. The Central Government supplements the efforts and resources of State Governments by a variety of measures in the arena of security and development.

### **Gorkhaland fury spreading to plains in North and West Bengal**

1002. SHRI N.K. SINGH: Will the Minister of HOME AFFAIRS be pleased to state:

(a) whether it is a fact that Gorkhaland fury has spread to the plains in the north of West Bengal with anti-statehood protesters clashing with supporters of the Gorkha Jana Mukti Morcha (GJMM) in the plains of Siliguri on 12th June, 2008; and

(b) the steps Government has taken to address the problem?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (DR. SHAKEEL AHMAD): (a) The Gorkha Janmukti Morcha (GJM) has been agitating and demanding separate Statehood for the area comprising entire Darjeeling district, including its Siliguri sub-division and certain contiguous areas in Jalpaiguri district (Dooars). There is resistance to this demand from various other organizations/groups. Agitational activities by either of the groups attract opposition from the other resulting in clashes like the one which occurred in Siliguri and adjoining area on June 12, 2008 when an organization, Amra Bangali and some others gave a call for a 48-hour bandh.

(b) The State administration of West Bengal took necessary administrative measures, including imposition of Section 144 Cr. PC in the disturbed areas. The Ministry of Home Affairs is regularly interacting with the Government of West Bengal with a view to ensuring the maintenance of law and order and peace in the area. Towards this end, and in pursuance of a demand from the GJM, and the request of the Government of West Bengal, the Central Government has also agreed to a process of Tripartite Talks between the GJM, Government of West Bengal and the Central Government. The first round of Tripartite Talks was held on 8 September, 2008.

#### **Foreign contributions to religious institutions**

SHRI RAJKUMAR DHOOOT:

Will the Minister of HOME AFFAIRS be pleased to state:

(a) whether religious institutions are allowed to receive foreign contributions; and

(b) if so, what was the extent of receipt of contributions, religion-wise?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI SHRIPRAKASH JAISWAL): (a) Yes, Sir.

(b) As per the data available and compiled for the year 2006-07, the total amount of foreign contributions utilized for religious purposes during the year was Rs. 683.22 crore. Religion-wise break-up is not maintained.

#### **Eruption of naxalite problem in Tamil Nadu**

1004. DR. K. MALAISAMY: Will the Minister of HOME AFFAIRS be pleased to state:

(a) whether it is a fact that the naxalite problem erupted in the recent past for the first time in Theni District, Tamil Nadu;

(b) if so, what are all the extra steps taken to nip at the bud, so that it may not get aggravated later; and

(c) the measures taken by the Central Government instead of totally entrusting the issue to the State alone?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI SHRIPRAKASH JAISWAL): (a) On 19th December, 2007, an exchange of fire between armed naxals and police took place in Theni district of Tamil Nadu. Though there was no casualty on either side, police recovered some arms and ammunitions.

(b) and (c) The State Government has been effectively dealing with naxal activities. The Central Government is supplementing the efforts and resources of State Governments by a variety of measures in the arena of security and development. These include assistance for capacity building of the State police and Intelligence agencies, sharing of intelligence and
