NREGA in Uttar Pradesh and Bihar

- 1050. SHRI KAMAL AKHTAR: Will the Minister of RURAL DEVELOPMENT be pleased to state:
- (a) the number of rural people employed under NREGA scheme during the last two years in Uttar Pradesh and Bihar, district-wise;
- (b) the details of the funds allocated to Uttar Pradesh and Bihar during the last two years, State-wise;
- (c) whether any assessment or monitoring has been done regarding utilization of fund in above said States; and
 - (d) if so, the details thereof and if not, the reasons therefor?

THE MINISTER OF STATE IN THE MINISTRY OF RURAL DEVELOPMENT (SHRI CHANDRA SEKHAR SAHU): (a) The basic unit for providing employment under NREGA is household and not an individual. District-wise number of households provided employment in Uttar Pradesh and Bihar, during the years 2006-07 and 2007-08, are given in the Statement (See below).

(b) NREGA is demand driven and not an allocation based programme. Funds released to these States during the past two years are as under

(c) and (d) Monitoring of NREG Act is a continuous Process. Performance of NREGA is monitored periodically by Minister (RD) and Secretary (RD) during fortnightly meetings, Performance Review Committee meetings and State specific review meetings. Feedback from States on financial indicators *i.e.* funds available/utilized, amount paid as wages, material and administrative expenses is obtained on monthly basis in the form of Monthly Progress Reports. These Reports are available on the web-site of NREGA. Further, the next tranche of central funds are released to the districts on utilization of 60% of available funds along with supporting documents on their claim. The Ministry of Rural Development requested C and AG to conduct performance audit of the implementation of NREGA for the year 2006-07. Accordingly, C and AG conducted performance audit of 68 districts, including six districts of Bihar and six districts of Uttar Pradesh for the period from February, 2006 to March, 2007. Final audit report of C and AG has been laid on the Table of the House on 24.10.2008.

Indira Gandhi National Old Age Pension Scheme

1051. PROF. P. J. KURIEN: Will the Minister of RURAL DEVELOPMENT be pleased to state:

- (a) whether 'Indira Gandhi National Old Age Pension' is implemented in all State;
- (b) if so, the details of State-wise number of beneficiaries and whether the number estimated by Government of Kerala and the Ministry of Rural Development are different;
 - (c) if so, the details thereof and the reasons for the difference; and
- (d) whether Government will consider giving pension to all persons as per the estimation of Government of Kerala?

THE MINISTER OF STATE IN THE MINISTRY OF RURAL DEVELOPMENT (SHRI CHANDRA SEKHAR SAHU): (a) Yes, Sir.

- (b) and (c) The State-wise number of beneficiaries under Indira Gandhi National Old Age Pension Scheme (IGNOAPS) at present is given at annexure in the statement (See below). The estimated number of beneficiaries under IGNOAPS as per 2004-05 poverty estimates of Planning Commission and projected population of the State as on 1.3.2006 for Kerala was 393000. However, the State Government of Kerala has intimated 7,22,801 number of people who are in the BPL List and 65 years or higher as per the preliminary survey reports held by the State Government agencies.
- (d) The State Government has been requested to cross check and rationalise the number of additional beneficiaries. All those persons who fulfill the eligibility criteria as per the guidelines of the scheme will be covered under IGNOAPS.
