THE MINISTER OF STATE IN THE MINISTRY OF CONSUMER AFFAIRS, FOOD AND PUBLIC DISTRIBUTION (DR. AKHILESH PRASAD SINGH): (a) to (e) As per information received from States & UT Governments by the end of November 2008, there are 4,97,715 Fair Price Shops in the country. During the last three years (*i.e.* from January 2006 to November 2008), 76249 Fair Price Shops licences were suspended/cancelled/Show Cause Notices were issued/FIRs were lodged against such licencees. 13348 persons were arrested/prosecuted/convicted. During the last three years, in 425 cases detention orders were passed under the Prevention of Black-marketing and Maintenance Supplies of Essential Commodities Act, 1980, by the State Governments/UT Administrations.

Evaluation reports on TPDS received in 2005 had pointed out diversion/leakages of TPDS foodgrains in a number of States & UTs. An allegation of diversion/leakages amounting to Rs.31500 crore was mentioned in a press report in September 2007 (Times of India dated 17.09.2007). However, this figure was highly exaggerated and misleading.

Subsequent reports on concurrent evaluation of TPDS by NCAER in 12 States have shown improved performance of TPDS in many of these States.

(f) Targeted Public Distribution System has been ensuring food security for BPL and AAY in the country.
