- (b) "Power Trading Corporation" is a private limited company and is known as "PTC India Ltd." According to information provided by the company, they have procured power from various sources at the rate indicated below:
 - (i) 5.050 MU from Calcutta Electricity Supply Company @ Rs.5.20/kWh.
 - (ii) 12.768 MU from Calcutta Electricity Supply Company @ Rs.3.50/kWh.
 - (iii) 22.752 MU from NCS Sugar @ Rs.3.75/kWh.
 - (iv) 1.348 MU from NCS Sugar @ Rs.4.00/kWh.
 - (v) 16.765 MU from Goa Energy Pvt. Ltd. @, Rs.2.40/kWh.
 - (c) PTC India have sold power to various utilities at the rates given below:
 - (i) 1.818 MU to Jaipur Vidyut Vitran Nigarn Ltd. @ Rs.5.24/kWh.
 - (ii) 1.818 MU to Ajmer Vidyut Vitran Nigam Ltd. @ Rs.5.24/kWh.
 - (iii) 1.414 MU to Jodhpur Vidyut Vitran Nigam Ltd. @ Rs.5.24/kWh.
 - (iv) 12.768 MU to Meghalaya State Electricity Board @ Rs.3.54/kWh.
 - (v) 22.752 MU to Noida Power Company Limited @ Rs.3.79/kWh.
 - (vi) 1.348 MU to Jharkhand State Electricity Board @, Rs.4.04/kWh.
 - (vii) 16.765 MU to Goa Electricity Department @ Rs.2.44/kWh.
