within first 3 in individual events or within first 2 in team events in a recognized National Championship, or have represented the country at least twice in an International Competition. The Scheme also provides for assistance to sportspersons injured or incapacitated during training or competition. The persons desirous of availing themselves of financial assistance under this scheme are required to apply to the Ministry. The applications received for such assistance are considered by a committee headed by the Sports Minister.

THE MINISTER OF STATE OF THE MINISTRY OF YOUTH AFFAIRS AND SPORTS (DR. M.S. GILL): (a) The details of budget provisions for the development of NER during 2007-08 were as under:—

- (b) The request for payment of balance Grant-in-aid is considered only within 12 months from the date of sanction letter or six months from the date of actual completion of the programmes, whichever is earlier, as per the terms and conditions of the sanction letter and on submission of the following documents namely:—
 - (i) Performance report indicating physical and financial target and achievements;
 - (ii) List of participants giving their name, Father/Husband name, age, complete permanent residential address, qualification, student/non-student and their category "SC/ST/OBC/Genl.";
 - (iii) Audited Statement of income and expenditure, and audited Statement of receipt and payment, balance sheet;

- (iv) Utilization certificate for the released amount of Grant-in-aid from Chartered Accountant on the prescribed form GFR-19A; and
- (v) Inspection report from the Recommending Authority conducted by the NGO.
- (c) to (e) Yes, Sir. The proposals of the organizations which fulfilled the parameters under the scheme were considered by the Project Appraisal Committee (PAC) and grants as admissible were released to the organizations subject to availability of funds.
- (f) The Revised Estimate budget provision for the year 2007-08 according to ten percent budget earmarked to NER was Rs. 68.25 crore. Out of this budget provision an amount of Rs. 63.44 crore was reported as utilized.
- (g) and (h) The details of Revised Estimate budget provisions for the NER component and expenditure for the last five years were as under:—
