## Minor forest produce

\*260. SHRIMATI T. RATNA BAI: Will the PRIME MINISTER be pleased to state:

(a) the Minor Forest Produce in each State, especially in Andhra Pradesh;

(b) the details thereof during the last four years; and

(c) the steps taken to give supporting price in this regard especially in Andhra Pradesh areas?

THE MINISTER OF STATE IN THE MINISTRY OF ENVIRONMENT AND FORESTS (SHRI S. REGUPATHY): (a) and (b) The Minor Forest Products (MFPs) consist of goods of biological origin other than wood, derived from forest, other wooded over as the Non-Wood forests. MFPs are known the world over as the Non-Wood Forest Products (NWFPs) or Non-Timber Forest Products (NTFPs). The number of MFPs differ in each State and generally include products like honey, sal seeds, Gum karaya, Tendu leaves, Mahua seeds, Myrobalans etc. The Government of Andhra Pradesh has notified certain forest based items the as MFPs and the details of these MFP items are given in the Statement-I (*See* below). The details of year-wise and commodity-wise procurement done by Girijan Cooperative Corporation (GCC) in Andhra Pradesh for the last four years is given in the Statement-II (*See* below).

(c) Girijan Cooperative Corporation (GCC) as an agent of Government of Andhra Pradesh is procuring the MFP from the Tribals on outright purchase basis organizing purchase centers in the tribal area. The endeavour of the Government of Andhra Pradesh is to pass on maximum benefit to the tribal MFP gatherer by way of remunerative purchase price for their produce. The mechanism for fixing up the Purchase Price is that the prevailing wholesale market price is taken as the basis and deducting the overhead charges and other incidentals, the purchase price is fixed. Since, the Government of Andhra Pradesh is subsidizing the staff costs and forest rentals, the burden of establishment cost of GCC and rentals are not loaded on the purchases price.
