Increase in Fake Ration Cards

THE MINISTER OF STATE IN THE MINISTRY OF CONSUMER AFFAIRS, FOOD AND PUBLIC DISTRIBUTION (SHRI ASHOK PRADHAN): (a) to (c) As per the population projections of 2000, there are 18.03 crores households in the country against which the States have reported issue of 19.92 crores ration cards. The excess ration cards include fake ration cards in the country.

As per the Targeted Public Distribution System (TPDS) guidelines issued in February, 1997 States/UTs have been asked to actively involve Panchayati Raj Institutions (PRIs) in the identification of targeted families and issue of distinctive ration cards to APL and BPL families. States have been instructed to take every care while issuing ration cards against its possible misuse. Guidelines issued for greater involvement of PRIs in functioning of TPDS, issued in June, 1999 emphasize the role of Gram Panchayats/Gram Sabhas for checking of ration cards for their genuiness. Government of India has also requested States/UTs to take effective steps for elimination of bogus ration cards and bogus units in ration cards through door to door surveys, periodical checks so that menace of diversion of subsidized foodgrains is effectively controlled. Government has recently notified Public Distribution System (Control) Order 2001 under Section 3 of the Essential Commodities Act, 1955, which interalia provides for periodical checking of ration cards to weed out ineligible and bogus ration cards and bogus units in the ration cards.

Selling of Sugar Quota in Open Market

- (a) whether sugar factories have been allowed to sell up to 10 per cent more than their quota in open market;

THE MINISTER OF STATE IN THE MINISTRY OF CONSUMER AFFAIRS, FOOD AND PUBLIC DISTRIBUTION (SHRI V. SREENIVASA PRASAD): (a) and (b) Yes, Sir. Keeping in view the requests received from the sugar factories for additional/advance quota of freesale sugar for clearing cane price dues and storage problem, the Government has allowed them to sell upto 10% of their quarterly quota over and above their normal quota within the quarter.
