Justice of India means the consultation with the collegium of the Judges which makes recommendation for the appointment. According to this interpretation of the Constitution, if the Government feels that the recommendation needs to be reconsidered, then it may be referred back to the Chief Justice of India for reconsideration. However, if the collegium reiterates the recommendation, then the proposal has to be referred to the President for approval. The same procedure has been followed in the latest appointments to the Supreme Court. There is no conflict between the Government and the judiciary. However, there have been demands from certain quarters for reconsideration of the law laid down in the Advocates-on-Records vs. Union of India.

Rural electrification

†*298. SHRI JAI PRAKASH NARAYAN SINGH: Will the Minister of POWER be pleased to state:

- (a) whether the rural area villages are covered under the electrification programme for the revenue village;
- (b) if so, whether under the revenue village, all the villages coming within a 20 km radius are being electrified;
 - (c) if so, the details in this regard pertaining to Jharkhand;
- (d) whether Government is aware that contractors are covering villages coming only within a 5 km radius for electrification under the revenue village; and
 - (e) if so, the steps being taken by Government in this regard?

THE MINISTER OF POWER (SHRI SUSHILKUMAR SHINDE): (a) Rajiv Gandhi Grameen Vidyutikaran Yojana (RGGVY) envisages electrification of about 1,15,000 un-electrified census revenue villages besides intensive electrification of already electrified census revenue villages.

- (b) All the census revenue villages including hamlets with population over 100 are eligible for electrification under RGGVY irrespective of the areas and radii of the census revenue villages.
- (c) As regards RGGVY in Jharkhand, all the 22 projects covering electrification of 16965 unelectrified villages, re-electrification of 2772 de-electrified villages and intensvie electrification of 7622 already electrified villages for providing over 29.26 lakh rural household connections including over 16.92 lakh Below Poverty Line (BPL) connections have since been sanctioned. Project-wise details are at Statement-I (See below).

Implementation Agencies have reported that rural electrification works in 3221 un-electrified villages and 1584 electrified villages have been carried out in the State of Jharkhand as on 01.12.2008 besides release of 97703 BPL household connections. The State has availed an amount of Rs. 1248.87 crore under RGGVY as on 01.12.2008. Project-wise physical and financial progress of RGGVY works in Jharkhand are at Statement-II (See below).

- (d) RGGVY has not envisaged any conditionally with respect to area or radius of villages for electrification.
- (e) So far no such case has been reported to Rural Electrification Corporation, the nodal agency of RGGVY.
