17 schoolchildren) were also killed. More than 150 persons received injuries. A large number of vehicles, both inside and outside the Chancery premises, were badly damaged. The Chancery building was also badly damaged. The attack on our Embassy was a dastardly terrorist attack perpetrated by the enemies of peace in Afghanistan and our region.

(c) and (d) Yes. A high-level team led by Secretary (West) in the Ministry of External Affairs visited Kabul from 7-10 July 2008. Foreign Secretary thereafter visited Kabul on 13-14 July 2008 along with other senior officers to review the situation arising out of the suicide attack. The security of the Embassy and its personnel has been augmented after the attack. The Afghan Government has been fully sensitised on providing adequate protection to Indian project workers and personnel in different parts of Afghanistan.

Agreement with Pakistan

683. SHRI Y.P. TRIVEDI:

SHRIMATI SUPRIYA SULE:

Will the Minister of EXTERNAL AFFAIRS be pleased to state:

- (a) the specific issues discussed with Government of Pakistan during his recent visit to Pakistan;
- (b) whether any agreement were signed between the two Governments as a result of the discussions held; and
 - (c) if so, the details thereof?

THE MINISTER OF EXTERNAL AFFAIRS (SHRI PRANAB MUKHERJEE): (a) to (c) The External Affairs Minister visited Pakistan on 20-21 May 2008. He reviewed the Composite Dialogue encompassing (i) Peace and Security, including CBMs; (ii) Jammu and Kashmir; (iii) Siachen; (iv) Sir Creek; (v) Wullar Barrage/Tulbul Navigation Project; (vi) Terrorism and Drug Trafficking; (vii) Economic and Commercial Cooperation; and (viii) Promotion of Friendly Exchanges in Various Fields, with his counter-part the Foreign Minister of Pakistan. It was agreed to continue with the implementation of Cross-LoC CBMs with a view to enhancing interaction and cooperation across the LoC. The importance of ceasefire in place since November 2003 was reaffirmed and the commitment to fight terrorism reiterated. During his visit he also called on the then President of Pakistan General (Retd) Pervez Musharraf, the Prime Minister Mr. Yousuf Raza Gilani, and other leaders. An Agreement on Consular Access was signed during the visit.
