- (c) and (d) Yes, Sir. 43 Wireless in Local Loop (WLL) Base Transceiver Stations (BTSs) of BSNL are under installation and order for supply of additional 126 WLL BTSs has been issued. On commissioning of these BTSs by the end of this financial year, most of the wait listed applicants will be provided telephone connection progressively.
- (e) Out of the total applications registered for provision of New Basic Telephone Connections (Wire & WLL) in the areas declared "on demand" in Rajasthan Telecom circle BSNL, 81.44%, 96.66% and 96.75% connections were provided within seven days of registration during the year 2005, 2006 and 2007 respectively.

Special Purpose Vehicle

- 635. SHRI GIREESH KUMAR SANGHI: Will the Minister of COMMUNICATIONS AND INFORMATION TECHNOLOGY be pleased to state:
- (a) whether taking a cue from railways, Ministry of Telecommunications and Posts is considering a proposal to set up a Special Purpose Vehicle (SPV) to develop vacant space of department of posts for commercial utilization;
- (b) if so, whether Ministry is considering SPV to be named Postal Land Development Authority and it will be on lines of Railway Land Development Authority;
- (c) whether Ministry has forwarded proposal to the Planning Commission, Finance Ministry and Urban Development Ministry for consultation and guidance;
 - (d) the reaction of these Ministries; and
 - (e) the time by which a final decision in this regard is likely to be taken?

THE MINISTER OF STATE IN THE MINISTRY OF COMMUNICATIONS AND INFORMATION TECHNOLOGY (SHRI JYOTIRADITYA MADHAVRAO SCINDIA): (a) to (d) There is no proposal to set up a Postal Land Development Authority. However, a proposal for setting up a Special Purpose Vehicle (SPV), a wholly owned company with limited liability and 100% equity participation by the Government, registered under the Companies Act, 1956, for optimum development and management of postal estates is under consideration of Government.

(e) At this stage, no time frame for setting up an SPV could be indicated.
