- (a) whether Government is aware that the steep increase in price of aviation fuel has resulted in fare hike by low cost airlines and consequently large scale prevention of air travel by middle class families in the country;
 - (b) if so, the details thereof and the reasons therefor; and
 - (c) the steps proposed to be taken by Government in this regard?

THE MINISTER OF STATE OF THE MINISTRY OF CIVIL AVIATION (SHRI PRAFUL PATEL): (a) and (b) Yes, Sir. Aviation Turbine Fuel (ATF) is a major component of operational cost of the Airlines. Airlines raised fare due to rise in prices of ATF. Passenger traffic has also been affected by the global financial downturn of the economy.

The number of domestic passenger fell to 30.48 lakh in November, 2008 as compared to 38.72 lakh in November, 2007.

- (c) The Government has taken various steps to help the domestic aviation industry which *Inter-alia* are as under:
 - (1) Custom duty on import of ATF has been abolished.
 - (2) The State Governments are being persuaded to reduce the sales tax on ATF. Government of Andhra Pradesh and in certain cases Government of Rajasthan have reduced the sales tax on ATF to 4%. Government of Maharashtra has also reduced sales tax on ATF from 25% to 4% for flights originating from airports other than Pune and Mumbai.
 - (3) The Oil Companies have also staggered the settlement of outstanding dues of Airline Companies over six months. Oil Companies have also extended the credit period.
 - (4) With the fall in global crude prices, the Oil Companies have been reducing ATF prices since September, 2008 and the prices are being revised fortnightly instead of monthly.

Airports in NER

- 2341. SHRI KHEKIHO ZHIMOMI: Will the Minister of CIVIL AVIATION be pleased to state:
- (a) the number and other details of airports, State-wise, in the eight States of North-East India, with dates of their establishment, number of flights operated, airline operator-wise;
- (b) the number of other details of helicopter services, State-wise, in the eight States of North East India, with dates of their establishment, the number of flights operated, airline operator-wise;
 - (c) the time by which the Chiethu airport will be completed in Nagaland; and
- (d) the details of work done and money invested so far for establishing the Chiethu airport in Nagaland with the date of commencement of work and date of investment of first installment of money?

THE MINISTER OF STATE OF THE MINISTRY OF CIVIL AVIATION (SHRI PRAFUL PATEL): (a) and (b) Total number of airports in North East Region (NER) is 23. The list of operational and Non operational airports, state-wise in NER, at present, is given in the Statement-I (See below).

The record of dates of establishment of these airports is not available since these have been in existence for more than past three decades.

Schedule air services in the NER, the airline-wise details are given in the Statement-II (See below).

At present in NER, Pawan Hans Helicopters Ltd. (PHHL) has provided helicopters on long term lease/wet lease to Governments of Meghalaya, Sikkim, Arunachal Pradesh, Tripura and Nagaland for regular passenger services for general public. PHHL operates them under the aegis of the respective State Governments as per their requirements.

- (c) Project is at formulation stage. Therefore, it is not possible to indicate a definite time frame.
 - (d) Does not arise in view of (c) above.

Parking slot at airports

2342. SHRI TARIQ ANWAR: Will the Minister of CIVIL AVIATION be pleased to state:

- (a) whether it is a fact that there is a shortage of space to park the private jets at the airports in Delhi and Mumbai;
 - (b) if so, the details thereof; and
 - (c) whether Government has any plan to develop more parking slots at these airports?

THE MINISTER OF STATE OF THE MINISTRY OF CIVIL AVIATION (SHRI PRAFUL PATEL): (a) Yes, Sir.

- (b) At CSI Airport, private jets operate from old airport apron which is an area on the south of the main runway. A portion of this apron where some of these private jets are currently parked, do not comply with the Civil Aviation Regulations and ICAO standards. As a result, this portion of Apron has to be decommissioned thereby causing shortage of aircraft parking space for private jets.
- (c) CSI Airport has, presently, no plans to develop more parking space for private jets due to land constraints. Facilities are soon to be expanded at Delhi airport.

Modernisation of Delhi and Mumbai airports

 - (a) whether modernisation of Mumbai and Delhi airports is lagging behind schedule;
