- (b) if so, the details of drug companies found involved in overcharging and selling without price approval in the last two years;
- (c) whether Government/NPPA have contemplated any action against such drug companies; and
  - (d) if so, the details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF CHEMICALS AND FERTILIZERS (SHRI B.K. HANDIQUE): (a) to (d) Since the inception of National Pharmaceutical Pricing Authority (NPPA) in August 1997, NPPA has raised a total demand of Rs. 1626.51 crores (up to 15.10.08) for recovery towards overcharged amount in 585 cases, under the provisions of Drugs (Prices Control) Order, 1995 (DPCO, 1995) read with Essential Commodities Act, 1955. NPPA has recovered Rs.131.72 crores so far (upto 15.10.08) from defaulting companies. NPPA continues to take appropriate action regularly for recovery of the overcharged amount. In some cases the recovery is affected, due to orders from the Hon'ble High Courts and Hon'ble Supreme Court of India and cases presently subjudice in Courts.

## Talcher fertilizer plants

(FCIL) subject to the confirmed availability of gas, various options for revival of the closed units including the coal based Talcher unit in Orissa and Ramagundam unit in Andhra Pradesh are being looked into by the Government.

The details will be worked out once the proposals for revival of each individual units are finalized.

## Control on life saving drugs

HANDIQUE): (a) and (b) Keeping in view the directions of the Supreme Court it has been proposed in the draft National Pharmaceuticals Policy-2006 that basket of drugs for price control would be the essential medicines as contained in the National List of Essential Medicines, 2003 (NLEM 2003) (subject to certain exemptions) in addition to the 74 bulk drugs which are at present under price control under the Drugs (Prices Control) Order, 1995.
