specific areas are identified considering persistence of thermal features, temperature gradients, meandering pattern etc. Such areas are known to be fish potential zones. Then fish prospect zones are marked on base maps with suitable geographical coordinates. This exercise takes about three to four hours after the receipt of satellite data.

(b) Yes, Sir. Information related to the location of fish prospect zones is disseminated to fisheries departments of respective maritime States through communication links. The information is then made available to local fishermen through vernacular newspapers and displays at the fishing harbour, and in some States through broadcast over All India Radio (AIR).
