THE MINISTER OF STATE OF THE MINISTRY OF FOOD PROCESSING INDUSTRIES (PROF' CHAMAN LAL GUPTA): (a) to (d) As per details made available by the Department of Agriculture and Cooperation, the total number of cold storages in the countn as on 31 -03-2001 arc 4199. The Slate-wise details arc given in ihc Statement (See below)

The High Level Expert Committee constituted by the Government of India to identify constraints and suggest remedial measures in the Sector has projected creation of cold storage capacity of 12 lakh lonnes. rchabilitation/moderni/ation of 8 lakh tonnes, and an additional 4.5 lakh lonnes for onion storage capacity in the countn during ihc Ninth Five Year Plan. In order lo give thursl to ihc cold storage sector, the Department of Agricillurc and Cooperation have introduced a scheme entitled. "Capital Investment Subsidy Scheme for Construction/ Expansion/Modernization of Cold Storages and Storages for Horticulture Produce". Under the scheme, financial assistance in provided in Ihc form of back-ended capital investment subsidy by the National Horticulture Board (NHB). and autonomous body under the Department of Agriculture and Cooperation through National Bank for Agricultural and Rural Development (NABARD) and National Cooperative Development Corporation (NCDC) (1\lambda 25\% of the project cost not exceeding Rs. 50.00 lakhs per project in general areas and (til 33.33% of the project cost up to a ceiling of Rs. 60 lakhs per project for North Eastern Slates. The scheme is demand based and the project proposal is to conic from eligible organizations. Government do not construct cold storages on their own.
