## Narmada Sagar Dam, Madhya Pradesh

959. SHRI SURESH PACHOURI: Will the Minister of ENVIRONMENT AND FORESTS be pleased to state:

- (a) whether it is a fact that a large forest area has been affected in the Narmada Sagar dam area in Madhya Pradesh;
  - (b) if so, what are the details thereof;
- (c) whether any afforestation plan has been initiated in the area by the Central and State Governments; and
- (d) if so, what progress Government have so far made in the afforestation of the area in Madhya Pradesh?

THE MINISTER OF STATE OF THE MINISTRY OF ENVIRONMENT AND FORESTS (SHRI KAMAL NATH): (a) and (b) Narmada Sagar Project involves diversion of 41,111.97 ha. forest area for which approval has been accorded under the Forest (Conservation) Act, 1980 on 7-10-87.

(c) and (d) As per stipulated condition, compensatory afforestation is required to be done over 10,141.848 ha. non-forest

area and 70,80,1.587 ha. degraded forest area. So far compensatory (affrestation has been done over 5,239 ha. of non-forest land and 23,048 ha. degraded forest land.

## Action plan to clean Narmada and Betwa Rivera

- 961. SHRI SURENDRA SINGH THA-KUR': Will the Minister of ENVIRON-MENT AND FORESTS be pleased to state:
- (a) whether Government have chalk ed out any 'Action Plan' for cleaning the water of inter-state rivers;
  - (b) 'f so, what are the details thereof;
- (c) whether Government have prepared any action plan for cleaning of Narmada and Betwa rivers in Madhya Pradesh with a view to remove pollutants from these rivers and make their water hygienic and worth drinking;
- (d) if reply to (c) be in affirmative, what steps have been taken by the Central Government so far to carry out the action plan; and
- (e) if reply to (c) be in negative, what steps Government propose to take to provide healthy and hygienic water from these rivers for drinking purpose?

THE MINISTER OF STATE OF THE MINISTRY OF ENVIRONMENT AND FORESTS (SHRI KAMAL NATH): (a) and (b) A National River Action Plan for abatement of pollution in the grossly polluted stretches of major inter-state rivers is under formulation. Details in this regard are being worked out.

(c) to (e) Pollution surveys in some stretches of the rivers Narmada and Betwa in Madhya Pradesh are in progress. Depending upon the results of these surveys and *inter-se* priority fixed therefrom, these stretches would be considered in formulating the proposed NRAP.
