ve threat to the environmental stability of the entire Indian sub-continent;

- (b) whether it is also a fact that fo rest cover in the Himalayas has been reduced considerably;
- (c) whether a major part of penisular India depends crucially on the Himalayas for monsoon; and
- (d) whether Government have formu lated any plan to preserve the Himala yan eco-system and check deforestation of its slopes if so, what are the details thereof, and if not, the reasons therefor?

THE MINISTER OF STATE OF THE MINISTRY OF ENVIRONMENT AND FORESTS (SHRI KAMAL NATH):
(a) There is no conclusive evidence to show that the eco-destruction of the Himalayas poses a grave threat to the environmental stability of the entire Indian sub-cotinent.

- (b) According to the 3rd and the latest assessment of the forest cover made by Forest Survey of India, Dehradun, based on the visual interpretation of satellite imageries pertaining to the period 1987—89, the actual, forest cover has not decreased in the Himalayas, except for Arunachal Pradesh in comparison to 2nd assessment of forest cover pertaining to the period 1985—87.
 - (c) No, Sir.
- (d) The Govtrnment have taken following steps to preserve Himalayan ecosystem and check deforestation;
 - (i) CR. Pant Institute of Himalayan Enronment and Development has been established to evolve effective strategies for management of natural resources and substantial development.
 - fi) An integrated Action Oriented Programme in the Himalayan Region has been launched.
 - (iii) Guidelines have been issued to State Governments from time to time for protection of forest. Some of these guidelines are as follows:
 - (a) To avoid clear felling of natural forests and where such fellings

- are inevitable for restoration of crop or other silvicultural considerations, it should be restricted to areas not exceeding 10 hectares in the hills and 25 hectares in the plains.
- (!•) To consider banning of feHingj in the hills above 1000 metres, at least for same years.
- (c) To identify critical areas in the hills and mountains which require protection from felling of forests and nied immediate vigorous afforestation.
- (d) To set apart of the geographical areas as protected area like wildlife sanctuaries, national parks biosphere reserves etc.
- (e) A massive afforestation pro gramme including Social Forestry and Agroforestry under 20 Point Programme in all States and UTs. has been uaunched. Upto the end of VIlth five year plan, an area to the tune of 17.09 million hectares has been brought under afforestation.
 - (f) Government of India have issued kuidelines for peoples' participation in management and development of degraded forests and their active involvement in afforestation pogramme.

Notification issued under the Environment Protection Act

- 950. SHRI YASHWANT SINHA: Will the Minister of ENVIRONMENT AND FORESTS be pleased to state:
- (a) whether by a notification issued on January 16, 1991 under the Environment Protection Act, the industries along the -Ganga were required to fulfill certain pollution control standards by 31st December, 1991:
- fb) whether the Supreme Court had also directed these units to file affidavits on the measures taken by them;
- (c) whether Government have since re laxed this deadline and given one more year's time to these industries;

- (d) if so, the reasons therefor; and
- (e) the present position of the case pending in the Supreme Court in this regard?

THE MINISTER OF STATE OF THE MINISTRY OF ENVIRONMENT AND FORESTS (SHRI KAMAL NATH): (a) The notification covered all polluting units in the country including those along the Ganga.

- (b) Yes, Sir.
- (c) and (d) On the basis of discussions with the State Governments, the following steps against the polluting industries has been notified:
- (i) The industries which have commenced producton on or before 16th May, 1981 and has shown adequate proof of at-least commencement of physical work for establishment of facilities to meet the specified standards within a time-bound programme, to the satisfaction of the concerned State Pollution Control Board, shall comply with such standards latest by the 31st December, 1993.
 - (ii) The industries which have commenced production after the 16th day of May, 1981 but before the 31st December, 1991 and have shown adequate proof of atleast commencement of physical Work for establishment of facilities to meet the specified standards within a time-bound programme, to the satisfaction of the concerned State Pollution Control Board, shall comply with such standards latest by the 31st day of December, 1992.
- (e) The cases with respect to (he tan neries and other indutsries except distilleries has been listed for March 31, 1992 and the cases in respect of distilleries have been listed for April 9, 1992.

Bodhghat Project in Madhya Pradesh

951. SHRI MOHINDER SINGH LATHER: Will the Minister of ENVIRONMENT AND FORESTS be pleased to state: .,

- (a) whether it is a fact that the Govern ment have received a request from the Madhya Pradesh Government for recon sidering the decision on Bodhghat Project; and
- (b) if so, the reaction of Government thereto?

THE MINISTER OF STATE OF THE MINISTRY OF ENVIRONMENT AND FORESTS (SHRI KAMAL NATH); (a) and (b) The Bodhghat Hydel Project was granted environmental clearance in 1979 and again in 1985, clearance under the Forest (Conservation) Act, 1980 was, however, not accorded due to non submission of data and plans, based on the study report received in February, 1992 the proposal is to be reexamined for forest clearance.

Power project of Karnataka for environment clearance

THE MINISTER OF STATE OF THE MINISTRY OF ENVIRONMENT AND FORESTS (SHRI KAMAL NATH-: (3) and (b) No, Sir.

Only two projects are pending clearance. These are:

- (i) Captive Power Plant of Kudremukh from Ore Company.
- (ii) Sarvathi Tail Race Hydro Electric Project.
