- (c> whether any agreement has since been signed between British Aerospace and Hindustan Aeronautics Limited; and
 - (d) if so, what are the details thereof?

THE MINISTER OF DEFENCE (SHRI SHARAD PAWAR): (a)

to (d) Hindustan Aeronautics Limited had received a proposal from British Aerospace for manufacture of the Advanced Turbo Prop. Aircraft in HAL. After preliminary discussions, the British Aerospace have been asked to revise their proposals to make the same economically viable.

to guard against the items sold reaching unintended destinations.
