

Regional imbalances in industrial development

1282. SHRI RAMACHAND- I RAN PILLAI : Will the PRIME MINISTER be pleased to state what measures Government propose to take to remove the existing regional imbalances in the matter of industrial development of the coun- try ?

THE MINISTER OF STATE IN THE MINISTRY OF INDUSTRY (SHRI P.J. KURIEN) : For promoting industrialisation of backward areas in an effective manner [Government introduced a Growth Centre Scheme in June, 1988. The Growth Centres which would be set up during the VIII Five Year Plan would be provided with all basic infrastructural facilities : like power, water, telecommunica- tion, banks etc. so as to attract industries to these areas. These would be developed at a cost of Rs. 25—30 crores each to be funded jointly by the Central Government, State Government and All India Financial Institutions.
