

(c) Escalation in the cost of all the inputs including fuel and feeds stock over the years accounts for increase in the cost of production. The consumer price of fertilizers is still below the cost of production and the landed cost of impor:.

(d) A Parliamentary Committee on Fertilizer Pricing has recently been constituted which is examining tie matter.

(e) and (f) India normally does not export chenvcal fertilizer.

### Drug Prices

1174. DR. SANJAYA SINH : Will the PRIME MINISTER be pleased to state :

(a) whether Government's attention has been drawn to the news items captioned "Despite patent protection Most Drug Prices to remain unaffected" appeared in the Indian Express dated the 19th December 1991;

(b) whether Government share the view that prices of 95 percent of the drugs produced in the country would remain unaffected even if India went in for patent protection and that the remaining 5 percent would be costly as stated by Mr. Geza Feketekuty the Senior policy advisor to the U.S. Trade Representative; and

(e) what are details in this regard ?

### Increasing the prices under new drag policy

THE MINISTER OF STATE IN THE MINISTRY OF CHEMICALS AND FERTILIZERS (CHIN-TA MOHAN) : (a) (and) (b) It has been the endeavour of Government to ensure easy availability of medicines in abundant quantity at reasonable prices to the consumers. This aspect is being borne in mind while reviewing the existing drug policy.

THE MINISTER OF STATE IN THE MINISTRY OF CHEMICALS AND FERTILIZERS (SHRI CHIN-TA MOHAN) : (a) to (c) Under the new Industriel Policy announced by Government in July, 1991, Indian companies are free to negotiate the terms of technology transfer according to their own commercial
