Artificial inputs to Jackup Consumer Prices

Will the PRIME MINISTER be pleased to refer to the answer to Unstarred Question 3068 given in the Rajya Sabha on 19th December, 1991 and state:

- (a) whether it is a fact that artificial input costs are used to jackup consumer prices;
- (b) what are the details of inputs where costs have gone up;
- (c) whether Government have verified the same;

- (d) if so, what was the earlier price taken and what is the present price;
- (e) whether it is a fact that formulation prices are hardly fixed based on purchase invoices; and
- (f) what are the names of folmulations, their earlier prices and their revised prices where increase of more than 20 per cent has taken place during the last six months?

MINISTER OF STATE IN THE MINISTRY OF CHEMI-CALS & FERTILIZERS (SHRI CHINTA MOHAN) : (a) prices of controlled formulations are fixed under DPCO, 1987 in accordance with a formula and fixed norms keeping in view the recommendations of the Bureau of industrial Costs & Prices (BICP) to whom all the relevant cost data, invoices etc. are furnished by the applicant company. As regards decontrolled formulations, the manufacturers are free to fix/revise the prices, However in case of unreasonable increase in the price of decontrolled formulation, Government intervenes and prevails upon the company to bring it to a reasonable level.

- (e) While fixing the price of controlled formulations notified or purchase price of the bulk drug, whichever is less, is taken into consideration.
- (h) to (d) and (f) Various inputs such as bulk drugs, excipients, packing materials etc. run into a large number. Besides the number of formulation packs sold in the market at present are in thousands. Time and labour involved in the collection, collation and compilation of the information will not be commensurate with the results likely to be achieved.
