Will you be able to produce those drugs which come under the American patents and by how much the prices of drugs and pharmaceuticals will go up as a result of Dunkel? Your preparatory work does not say that. You sent it to the Cabinet Sub-Committee. You must have done some preparatory work.

**SHRI CHINTA MOHAN:** The whole question of Dunkel proposals, as I already said, is under examination by the Cabinet Sub-Committee, and my Department will also be reviewing it. If the hon. Member wants it, we will write to him. (Interruptions)

**SHRI KAMAL MORARKA:** Sir, I want to know from the hon. Minister this. The Dunkel proposals may be under the examination of a Cabinet Sub-Committee. You are not competent to answer; it is fine. You are well aware that the drug industry is a major industry that would be affected by these proposals. Your Ministry is the administrative Ministry for the drug industry. What is the view of your Ministry as conveyed to the Prime Minister or to the Cabinet with respect to the Dunkel proposals? Has your Ministry crystalised its views and if so, what are these?

**SHRI CHINTA MOHAN:** At present I cannot say anything. We are studying the entire gamut of proposals.

#### Disinvestment of Defence Land Holdings

\*237. **SHRI HIPHEI:** Will the Minister of DEFENCE be pleased to state:

(a) whether Government plan to disinvest ten per cent of defence land

holdings with a view to generate additional financial resources; and

**THE MINISTER OF DEFENCE**

(b) There is no plan to disinvest 10 per cent of the Defence land holdings. However, Government are examining the possibility of generating additional resources by disposing of lands which may be surplus to Defence requirements.

**SHRI HIPHEI:** Sir, what is the exact area of the surplus land after Defence requirements?

**SHRI SHARAD PAWAR:** Sir, the Defence Ministry has got more than 22,16,000 acres of land, and out of that about 30 per cent land is under use. The rest land is vacant. We are trying to get information from the respective Wings as to which land we will be able to dispose of. That information has not yet been received.
