## Forest convention

**3040.** SHRI SANTOSH BAGRODIA: Will the Minister of ENVIRONMENT AND FORESTS be pleased to state: What is Government's reaction to the proposed Forest Convention on Environment and Development and Biodiversity Convention to be held at Brazil?

THE MNISTER OF STATE OF THE MINISTRY OF ENVIRONMENT AND FORESTS (SHRI KAMAL NATH): The UN Conference on Environment and Development (UNCED) is to be held in Brazil in June 1992. Among a number of other subjects, this Conference is also likely to discuss principles of forestry and issues related to a biodiversity Convention which is being separately negotiated under the auspices of the United Nations Environment Programme.

THE MINISTER OF STATE OF THE MINISTRY OF ENVIRONMENT AND FORESTS (SHRI KAMAL NATH): (a) The Ganga Action Plan has not dealt with diversion of river Ganga between Kanpur and Varanasi because the Ganga Action Plan is aimed at taking steps for pollution abatement of the river only.
