(a) whether Government's attention has been drawn to the report published in the 'Indian Express' of 9th March, 1992 under the heading "PHRO flays Ribeiro statement";

(b) if so, what are the details of the interview given by the Indian

Ambassador to Romania about the human rights groups;

(c) whether it is a fact that the Indian Ambassador described the human rights group as a bunch of mis-guided lawyers-misdirected terrorists and demanded a closer look into its credentials- and

(a) if so, what is Government's reaction thereto?

IRO): (a) Yes, Sir

(b) to (d) It has been ascertained that the Ambassador did not give any formal press interview. However, in an informal discussion with an Indian journalist in Bucharest, he had, when asked about the trial in Romania of those who had attempted to assassinate him, mentioned that it was misguided on the part of representatives of PHRO to have asked for the release of the assailants and his recall from Romania.

Visit of IT. S. Senator Pressler to India

3268. SHRI YASHWANT SINHA:

Will the Minister of EXTERNAL AFFAIRS be pleased to state:

(a) whether the U. S. Senator Larry Pressler visited India recently;

(b) whether he visited on the invitation of the Government of India or on his own;

(c) what are the names of the functionaries of the Government of India he met during his stay in India; and

(d) what was the outcome of his visit?

THE MINISTER OF STATE IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI EDUARDO FALEIRO): (a) Yes, Sir.

(b) He visited India on his own.

(c) Senator Pressler met amongst others Prime Minister, External Affairs Minister, Raksha Mantri, Minister of State for Commerce, Foreign Secretary, Defence Secretary, Secretary Department of Atomic Energy, and Chief of Army Staff.

(d) Senator Pressler has stated that he acquired a better understanding of India's viewpoint on the problems of regional security and non-proliferation issues in the context of the Pressler Amendment.

मुसलमानों को बर्मा छोड़ने पर मजबूर किया जाना

विदेश मंत्रालय में राज्य मंत्री (श्री एडुआर्डो फेलेरियो) : (क) सरकार को इस बात की जानकारी है कि पिछले दिनों में म्यानमार से बहुत बड़ी तादात में लोग बंगलादेश आए हैं।

(ख) सरकार ने इस स्थिति पर चिन्ता जाहिर की है। बंगलादेश में बड़ी तादाद में इन लोगों के आने के परिणामतः उसे जिन दिक्कतों का सामान करना पड़ रहा है उन्हें देखते हुए हमने उसके साथ अपनी सहानुभूति व्यक्त की है और साथ ही इस समस्या के किसी शान्तिपूर्ण समाधान के लिए उसके प्रयासों का समर्थन भी किया है; इस समय इस मामले पर सार्क के तत्वावधान में किसी कार्रवाई पर विचार नहीं किया जा रहा है।
