Direct flight between Delhi and Visakhapatnam

Will the Minister of CIVIL AVIATION AND TOURISM be pleased to state:

(a) what is the present status of the long pending public demand to restore the direct flight between Delhi and Visakhapatnam;

(b) whether there is any proposal with Government to restore all the flights discontinued after the grounding of A-320 Airbuses after the Bangalore accident; and

(c) if so, what are the reasons for not restoring these flights?

THE MINISTER OF CIVIL AVIATION AND TOURISM (SHRI MADHAVRAO SCINDIA): (a) Indian

Airlines has no plan at present to restore the service between Delhi and Visakhapatnam due to capacity constraints.

(b) and (c) While most of the services which were withdrawn due to the grounding of Airbus A-320 aircraft have already been restored, the remaining services have not yet been restored due to commercial and operational reasons.

Development of Ajanta and Ellora with Japanese Assistance
