-All industrial growth centres, tourist and pilgrimage.centres to be provided NSD facility by 1.4.1995.

(c) Telephone Exchanges at 53 stations in the state of Madhya Pradesh have National Subscriber Dialling facility enabling them to dial into all the exchanges of the country having National Subscriber dialling facility. The list of these 53 stations is given in the satement attached.
