India's urge to European Community for the grant of generalised scheme of preferences

THE MINISTER OF STATE OF THE MINISTRY OF COMMERCE (SHRI P. CHIDAMBARAM): (a) to (c) EEC introduced the scheme of Generalised System of Preferences in 1971. India has been a beneficiary of the scheme since its inception. At the Indo-EEC Joint Commission held in November, 1991, the EEC was requested to improve the scheme through additional coverage and simplification. EEC is reviewing its
