# Modernisation of Country's Telecommunication System

- \*2. SHRI ARANGIL SREEDHARAN: Will the Minister of COMMUNICATIONS be pleased to state:
- (a) whether Government propose to modernise the country's telecommunication system; and
  - (b) if so, what are the details thereof?

THE DEPUTY MINISTER IN THE MINISTRY OF COMMUNICATIONS (SHRI P. V. RANGAYYANAIDU): (a) Yes, Sir.

(b) Statement is placed on the Table of the House.

### Statement

To modernise the telecommunication services in the country, the draft 8th Plan proposals include:

- full automatisation of network by March, 1994.
- replacement of life expired and worn-out equipment by electronic equipment.
- provision of additional 3000 route kilometres of ducts for underground cables.
- practically all new equipment proposed for induction during the

- 8th Plan period to be of digital type.
- Further computerisation of telecommunication services such as directory enquiry, billing, manual trunk service, etc.
- Further induction of modern store and forward technique telegraph equipment to modernise the telegraph network.
- Use of improved computerised network management techniques.
- Provision of the following valueadded services in all towns with a population of 5 lakhs or more:
  - Voice-mail service
  - Electronic-mail service
  - Audio-conferencing service
  - Video-conferencing service
  - Radio-paging
  - Videotex
- Provision of cellular mobile phones in major cities.

SHRI ARANGIL SREEDHARAN: Mr. Chairman, Sir, our telecommunication system is notorious for its inefficiency and gross disregard for the customer service. The statement has not pointed out what achievements will be made as a result of modernisation of the telecommunication system and what the objectives are. We have a long list of applicants for telephone connections both in the cities and the rural areas. Will the Minister be able to assure this House that with the finalisation of this programmes, arrears of applications for telephone connections will be wiped out and that this system which is being organised will give more telephone facilities to rural areas?

THE MINISTER OF STATE OF THE MINISTRY OF COMMUNICATIONS (SHRI RAJESH PILOT): Mr. Chairman, Sir, I have been answering questions earlier in the House that we have put our best efforts to make the services more efficient. It is a public service. There is always some lacuna somewhere. I am not saying that we have a perfect service today. But efforts have been made to improve the service. In the next Five-Year Plan we have put stress on modernisation of our technology, to

computerise our technology, to computerise our network and also introduction of new, modern telecom services. With our efforts, the hon. Member is aware that specially regarding the big waiting list in Delhi and Bombay, we have brought the OYT waiting list to zero on 30th June, 1991. Similarly, we have taken other steps in other places, and we are hopeful that the waiting list of 23 lakhs as on today, this year, we are likely to bring down.

Till now we have never crossed 4 lakh connections. But this year we are likely to touch 6.5 or 6.8 lakhs. so, this will bring the waiting list down.

Sir, as far as the rural connections are concerned, it is for the first time that our Government has taken it up with the Planning Commission. We have assured the country that by March, 1995 all panchayat headquarters will have PCOs. All districts will be connected with STD facilities by March, 1992 this year. All exchanges in the country will get STD facilities by March, 1997. All exchanges will be changed over to electronic by March, 1997. It was 2.8 per cent in March, 1985. We have touched 49 per cent today. By the end of the Plan we hope that we will certainly touch 90 per cent plus electronic exchanges. All these efforts are on.

I would request the hon. Member to go to one of the rural areas, to go to those areas which are totally remote and see how much we have progressed in communication. After that he can comment on our efficiency.

SHRI ARANGIL SREEDHARAN: He is asking me to go to the rural areas. He should know that I have come here from the rural areas. I have to ask my second supplementary.

MR. CHAIRMAN: What is it?

SHRI ARANGIL SREEDHARAN: He is asking me to go to the rural areas. I have come from the rural areas. I have worked in the rural areas. I have not come through the backdoor like him.

MINISTER OF CIVIL AVIATION AND TOURISM (SHRI MADHAV RAO SCINDIA): (a) and (b) Government of India has signed a Loan Agreement with the overseas Economic Cooperation Fund of Japan on 9th January, 1992 for financial assistance OECF for comprehensive development for the Ajanta and Ellora Region. The total project cost is 4,406 million Yen (Rs. 81.71 crore approximately).

OF MINISTER CIVIL AVIATION AND TOURISM (SHRI MADHAV RAO SCINDIA): (a) Yes, Sir.

- (b) The names are indicated in the statement attached [See below]. In addition, the Indian Missions in USA, UK, France, Germany, Italy, Singapore, Canada and Japan were also requested to advise the well known international foreign chains in their region about this scheme.
- (c) and (d) The broad outline of the scheme indicated to them was that the India Tourism Development Corporation wishes to group its various properties in small groups and develop them through a joint venture company to be formed with them, a portion of the capital being also employees/public/financial offered to institutions.
- (e) The Federation of Hotel and Restaurant Associations of India have represented that the Indian hotel chains may also be permitted to participate in this scheme.
- (f) As a much wider range objectives was being served by the scheme as formulated, it was not found feasible to agree to other suggestions.
