(d) by when they would be posted in Delhi?

THE MINISTER OF STATE IN THE MINISTRY OF PARLIAMENTARY AFFAIRS AND THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI M.M. JACOB): (a) Non-Gazetted personnels of CRPF who are on the verge of retirement are considered for choice/home posting to the extent administratively possible to crable them to sort out their domestic problems on the following conditions:—

- (i) such personnel are adjusted within the prescribed limit of 50% strength of natives in a particular Group Centre.
- (11) The individual has not availed static postings during the preceeding 3 years.
- (iii) The period of such postings should not normally exceed 2 years.

However, no such facility has been extended to gazetted officers of CRPF.

- (b) Shri R. N. Yadav, Commandant, CRPF, is the only officer due to reifre in 1994, who had applied in December, 1991 for his posting either to Delhi, Ajmer, Gandhinagar or Rampur.
- (c) Saci R. N. Yadav had already remained posted in Delhi, and he was approved for posting out of Delhi prior to receipt of his application for choice posting.
- (d) Sari R. N. Yadav has joined the present place of posting on 17th January, 1992. He would be considered for choice posting at an appropriate time.

Rotational Posting in C.R.P.F.

- (a) what are the details of the rule under which officers and other ranks in C.R.P.F. are not allowed to remain posted at one place for more than three years;
- (b) what are the names of the officers of the rank of Asstt., Commandant, II-Ic (two IC), and Commandant, who have remained posted in Delhi for more than three years, by securing posting from one Delhi based battalion to another or to an office of C.R.P.F. in Delhi.

cularly young officers at the cost of some officers with genuine difficulties; and

(d) whether Government propose to order an enquiry in the matter; if so, by when; and if not, the reasons therefor?

(a) There is no rule which prevents posting of officers and personnel in other ranks in CRPF to remain posted at one place for more than three years.

 - (1) Shri S.C. Mishra, Commandant
 - (2) Shri B.R. Sharma, Commandant
 - (3) Shri Rajender Singh, Commandant
 - (4) Shri K.S. Rana, Commandant
 - (5) Shri R.K. Sharma, Commandant
 - (6) Shri S.P. Srivastava, Second-in-Command.
 - (7) Shri D.C. Pathak, Second-in Command.
- (d) No, Sir. No enquiry is proposed since there has been no violation of rules or regulations in this matter.
