# **ORAL ANSWERS TO QUESTIONS**

## **Export of Tobacco to Algeria**

\*301. SHRIMATI JAYAPRADA NAHATA : †
DR. ALLADI P. RAJKUMAR :

Will the Minister of COMMERCE AND INDUSTRY be pleased to refer to the answer to Unstarred Question 2959 given in the Rajya Sabha on the 21st August. 2000, and state:

- (a) whether Government/Tobacco Board have intervened to settle the matter between M/s Best India Tobacco Suppliers and M/s SNTA;
  - (b) if so, the details of the steps taken in this regard;
- (c) whether tobacco exports have been talcing place since 2000 onwards without any regard to the settlement of discontinued imports of tobacco by M/s SNTA of Algeria from India: and
- (d) if so, the details of tobacco exports that have taken place during the last three years including the current financial year?

THE MINISTER OF STATE IN THE MINISTRY OF COMMERCE AND INDUSTRY (SHRI RAJIV PRATAP RUDI): (a) to (d) A Statement is laid on the Table of the House.

#### Statement

- (a) and (b) Tlie dispute between M/s Best India Tobacco (P) Ltd.. Guntur, and M/S SNTA. Algeria relates to a contract signed between M/s SNTA and three Indian tobacco exporters in 1991 for supply of 3500 tonnes of tobacco over a three-year period. The dispute centres on a claim preferred by M/s SNTA for weight loss compensation of 230 tonnes of tobacco on account of insect infestation. Although this is essentially a commercial dispute between two companies. Government of India has acted to encourage a mutually satisfactory conclusion to this dispute. The Indian exporter has been directed to settle the matter with the Algerian party, with the Tobacco Board strictly playing the role of facilitator. A delegation led by Chairman. Tobacco Board, to Algeria in Feburary 2000. had also made an attempt to help in settling this dispute. However, the dispute remains unresolved till date.
- (c) and (d) M/s SNTA.which is the Algerian Government tobacco monopoly, had discontinued import of tobacco from India since 1994. According to data from the Directorate General of Commercial Intelligence & Statistics, the

total tobacco export to Algeria over the period 1995-2000 was nil. In the period 2000-2001. non-Flue Cured Virginia tobacco lias been exported in small quantities to Algeria. The details of tobacco export to Algeria over the past four years are as follows:
