JACOB): (a) to (d) Between 1st January and 15th February, 1992 only one incident of infiltration on the Line one incident of infiltration on the Line of Control came to notice. During this period, on the Line of Control a total of 4 terrorists were killed and one arrested, and in terrorist violence in the State 14 security force personnel and 48 civilians were killed. The payment of ex-gratia assistance to the victims of the terrorist violence including the security force personnel is governmed by the scale prescribed in the Government of Jammu and Kashmir Order No. 723-GR (GAD) of 1990, dated 10-7-90.

The Government has stepped up vigil on the border to check infiltration exfiltration and has further intensified the Intelligence operations.

The National Integration Council on 31st December, 1991 and an all Party Conference on 10th February, 1992 also deliberated on the situation in Jammu and Kashmir. the situation in Jammu and Kashmir.

This is a continuous process and as on date the number of such references is 1321.

Killings by Terrorists in Uttar Pradesh

284. DR. SANJAYA SINH: Will the Minister of HOME AFFAIRS be pleased to state the number of killings perpetrated by Punjab based Terrorists in Terai regions of Uttar Pradesh during the last year till date?

THE MINISTER OF STATE IN THE MINISTRY OF PARLIAMENTARY AFFAIRS AND THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI M. M. JACOB): From 22-2-1991 to 21-2-1992, a total number of 245 persons were killed in the State in terrorist activities, among them 28 were police personnel, 53 Sikhs and 132 non-Sikhs. A total of 32 extremists were also killed during this period.

Ban on Bhutan Lottery
