(c) It is the endeavour of the Government to encourage exports of engineering goods including brass-goods. Measures to increase the export of engineering goods including brass-goods consists of various provisions under the Export-Import Policy including, *inter alia*, duty Exemption Scheme. Export Promotion Capital Goods Scheme. Duty Drawback Scheme. Exemption under Section 80 HHC of Income Tax Act Assistance from Market Development Fund etc. Engineering Export Promotion Council (EEPC) provides support through various activities with a view to promoting exports of engineering goods including brass-goods to various markets.

Further, with a view to boosting the export of Art Metal ware including brass art ware various steps have been taken by the Government which. *inter alia*, include participation in *International* fairs and exhibitions, sponsoring sales-cum-study teams abroad to explore overseas market opportunities, promotion through preparation of product catalogues of international standards, setting up of India Exposition Mart for round the clock international marketing.

Promotion of leather export

- ^ THE MINISTER OF STATE IN THE MINISTRY OF COMMERCE AND INDUSTRY (SHRI RAJIV PRATAP RUDI): (a) lo (c) India's exports of leather and leather products during April-August. 2001 was of US \$ 845.74 million against US \$ 828.21 million during the corresponding period of last year, thus recording a positive growth of 4.64%. Council for Leather Exports has brought to the notice of the Government that while companies like timber Land have suspended their further procurement of shoes and leather products from India, some other companies have expressed their concern over the use of cow leather in the manufacture of shoes and other accessories.
- (d) Government have taken a number of steps including establishing of contacts with such multi-national organisations and addressing of issues raised by these organisations and undertaking product specific export promotion programmes in the overseas markets, inviting delegations from abroad and stepping up of marketing promotion efforts in the US and Japanese markets as well as consolidation in European market.
