### **Ban on Tuitions**

THE MINISTER OF HUMAN RE SOURCE DEVELOPMENT (SHRI ARJUN SINGH): (a) to (c) No Sir. Private paid tuition by Central Govern ment teachers is already prohibited under the Central Civil Services (Conduct) Rules. As for prohibition of tuitions by teachers in State Governments, State Governments were advised in 1989 to take appropriate steps to curb the practice of private tuitions by their teachers. Education Acts of some StatesjUt Administrations also ban private tuitions.

THE MINISTER OF HUMAN RE SOURCE DEVELOPMENT (SHRI ARJUN SINGH): (a) Under the scheme entitled "Financial Assistance to Artistes in Indigent Circumstances" 561 reputed artistes are receiving financial assistance.

(b) According to the Scheme, a per son: (i) should have made significant contribution to arts and letters etc. (traditional scholars who have made significant contribution in their respective fields are a"so eligible, absence of any published works notwithstanding), (ii) should not have personal income, including income of his spouse of more than Rs. 1,000[per month and (iii) should not be less than 58 years of age (this age limit does not apply to the dependants of reputed artistes).

It is proposed to enhance the quantum of financial assistance from Rs. 600l- to Rs. 1000l- per month, w.e.f. 1-4-1992.

(c) The 561 artistes, belonging to the various disciplines of culture and art aire drawn from all over the country.

THE MINISTER OF HUMAN RE SOURCE DEVELOPMENT (SHRI ARJUN SINGH): (a) to (c) As per the information received from the Govern ment of Jammu and Kashmir the number of stipendiary engineers unemployed in Jammu and Kashmir is, 1297, who could not be offered employment for want of adequate number of posts and in view of the time taken in the selection process. They have been sitting on Dharna from time to time. However, no immolation has taken place.
