

Minimum specifications for Nursery Schools

4146. SHRI BHUBANESWAR KALI-IA: Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:

(a) whether it is a fact that the National Council of Education Research and Training (NCERT) have set the minimum specifications for the Nursery Schools; and

(b) if so, whether these specifications have been implemented and if not, the reasons therefor?

THE MINISTER OF HUMAN RESOURCE DEVELOPMENT (SHRI ARJUN SINGH): (a) and (b) NCERT has recently developed draft minimum specifications for Nursery Schools, which have been circulated widely and comments/ Miggestions invited thereon. Specifications and norms are generally not finalised and communicated to State Governments for implementation without due consultation with them.

Anganwadi Centres

(a) the number of Anganwadi Centres, workers and helpers in Karnataka;

(KUMARI MAMATA BANERJEE): (a) Under 'integrated Child Development Services Programme in Karnataka 22164 Centres under central sector and 3284 Centres under State Sector are sanctioned. Accordingly, 22164 Anganwadi Workers and 22164 Helpers under Central Sector and 3284 Anganwadi Workers and 3284 Helpers under State Sector are sanctioned.

(to) Yes, Sir. The Anganwadi Workers have been demanding status of Government Servants and improvement in financial benefits particularly the rates of monthly honorarium.

(c) Government is unable to accept the demand for giving the status of government employees to Anganwadi Workers and Helpers as it will be against the basic principles of the Integrated Child Development Services Scheme. The Scheme is based on voluntary and community participation of village women who work on part time (41/2 hour, daily) basis as voluntary workers selected from the local community. As regards, revision of honorarium of the Anganwadi Workers and Helpers, the matters is receiving Government's utmost attention.
