**Financial assistance to milk corporation under operation flood Scheme**

\*411. DR. ABRAR AHMED:

SHRI BEKAL UTAHI:

Will the Minister of AGRICULTURE be pleased to state:

(a) whether Government provide financial assistance to various milk supply corporations under the Operation Flood Scheme;

(b) the details of the beneficiaries of this scheme during the last three years, year-wise;

(c) the number of milk corporations which are running at losses;

(d) whether some State Government have requested the Central Government to increase the financial assistance to minimise the losses;

(e) if so, the details thereof; and

(f) the reaction of Government thereto?

THE MINISTER OF AGRICULTURE (SHRI BALRAM JAKHAR): (a) and (b) Under Operation Flood-III, financial assistance is generally provided to State Dairy Cooperative Federations being the implementing agencies for the Operation Flood (OF) programme. Gujarat Dairy Development Corporation (GDDC) is the only dairy corporation designated as an implementing agency for the OF Programme in four districts of Gujarat.

(c) The cumulative loss of GDDC as on 31-3-1989 was Rs. 11.86 crores.

(d) and (e) No proposal has been received from GDDC for financial assistance.

(f) Does not arise.

**Unserviceable machines in Govt. Press, Minto Road, New Delhi**

(a) to (c) An ancilliary equipment of 'System-272' of Monotype U.K., the equipment procured in 1983, has only been operating intermittently due to technical defects which the local representatives of the manufacturer have not been able to rectify. As such, it is proposed to explore other local sources to get the defects rectified.

**Indira Gandhi National Centre for Arts**

\*414. **SHRI MENTAY PADMANABHAM:** Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:

(a) what are the activities of the Indira Gandhi National Centre for Arts;

(b) what were the annual allocations for the IGNCA during the last three years; and

(c) what is the monitoring apparatus for IGNCA?

**THE MINISTER OF HUMAN RESOURCE DEVELOPMENT (SHRI ARJUN SINGH):** (a) The Indira Gandhi National Centre for the Arts encompasses all the arts in their dimension of the past and present dialogue between India and

cognate cultures and other disciplines of science and philosophy and the continual interplay of the rural and the urban, the oral and the textual. The activities of the Centre are carried out through the following four Academic Divisions: (1) Kala Nidhi; (2) Kala Kosa; (3) Janapada Sam-pada; and (4) Kala Darsna. The specific activities of each one of these Divisions are as follows:—

(1) *Kala Nidhi:* Establishment of a Reference Library of multi-media collections for the purpose of research in humanities and the arts; a computerised National Information System and Data Bank on arts, humanities and cultural heritage; and cultural archives on collections of eminent scholars, artists, musicians, dancers, sculptors, etc;

(2) *Kala Kosa:* Programme of research on fundamental terminology re-
