- (c) The production of total oilseeds, and sugarcane have increased in 1990-91 over 1989-90. However, cotton production in 1990-91 showed some decline over the previous year.
- (d) The cotton production was adversely affected during 1990-91 due to incidence of pests and diseases in the northern region and adverse whether conditions in the western region of the country.

Export of Milk

4049. SHRI SHAMIM HASHMI: Will the Minister of AGRICULTURE be pleased to state:

- (a) whether white revolution has resulted in surplus milk and if so, the details of milk exports made year-wise at the completion of Operation Flood and foreign exchange earned:
- (b) what was the corresponding national value of gift milk powder and butterfat imports and value of commercial import and foreign exchange spent;
- (c) whether Government propose to continue to rely on gift and commercial imports, and if so, the reasons therefor; and
- (d) whether, instead of gift milk imports, Government propose to seek gifts of wheat to save scarce foreign exchange?

THE MINISTER. OF STATE IN THE MINISTRY OF AGRICULTURE (SHRI K. C. LENKA): (a) The estimated milk production in India has gone up from 21.2 million tonnes in 1968-69 to 53.7 million tonnes (provisional) in 1990-91 as against the nutritional requirement of 67 million tonnes of milk in 1990-91.

(b) The value of gift skimmed milk powder (SMP) and butter oil (BO) and butter received from the European Economic Community (EEC) under Operation Flood-II and HI from 1978-89 to 198-90 Is of the order of about Rs. 440.94 crore. There has been no receipt of gift commodities after August, 1989. The CIF value of commercial import of

- SMP and BO during 1987-88 to 1989-90 is of the order of Rs. 67.12 crore and the foreign exchange expenditure on these imports was about US \$ 4.26 crore.
- (c) The gift imports of dairy commo dities are being received from EEC for Operation Flood-Ill programme. The commercial import of dairy commodities depends upon the circumstances from time to time.
- (d) There is no such proposal under consideration of the Government at present.

National Institute of Animal Nutrition and Physiology
