Transfer of Kendriya Vidyalaya Teachers

653. SHRI ANAND PRAKASH GAUTAM : Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state :

(a) whether it is a fact that about 500—600 teachers of Kendriya Vidyalayas have been transferred at the instance of the Chairman of Kendriya Vidyalaya Sangathan during July 1991—January, 1992 ;

(b) if so, whether AIKVTA has alleged that these transfer orders are violative of KVS' transfer Guidelines and should be reviewed ;

(c) if so, whether the demanded review has since been undertaken ; and

(d) if so, the details in this regard; and if not, the reasons therefor ?

THE MINISTER OF HUMAN RESOURCE DEVELOPMENT (SHRI ARJUN SINGH) : (a) to (d) Transfers are generally made as per the transfer guidelines. The Chairman, Kendriya Vidyalaya Sangathan, under his discretionary powers has allowed transfers on extreme compassionate grounds, spouse cases and administrative exigencies etc. Specific cases brought to the notice of the Sangathan by the individual concerned and various service associations including 22 cases submitted by All India Kendriya Vidyalaya Teachers' Association from time to time are reviewed and appropriate orders are issued.

Operation Black Board

655. SHRI PRAMOD MAHAJAN : Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state what is the assessment of Government about the implementation of 'Operation Black Board'?

THE MINISTER OF HUMAN RESOURCE DEVELOPMENT (SHRI ARJUN SINGH : The Scheme of Operation Black Board was launched in 1987-88 with a view to bring about substantial improvement of facilities in all Primary

schools in the country. It was envisaged to implement the scheme in a phased manner by covering 20% Blocks in 1987-88, 30% in 1988-89 and remaining 50% during 1989-90. However, due to a constraint on resources phasing had to be lengthened. So far 5275 Blocks (82.46%) comprising 403931 (75.17%) Primary schools in the country have been covered. Till date Rs. 618.59 Crores have been sanctioned to States/UTs as Central Assistance under the Scheme. 114903 posts of Additional teachers in single teacher schools have been sanctioned. It is proposed to continue the Scheme during the VIII Plan till all the remaining Blocks are covered.
