Sharing of river waters with Bangladesh

*77. SHRI KAPIL VERMA: SHRIMATI VEENA VERMA:

Will the Minister of WATER RESOU-RCES be pleased to state :

- (a) whether it is a fact that India and Bangladesh have agreed on sharing of waters of four common riv ers;
- (b) if so, whether any guiding principles have been enuciated in this regard; and
- (c) the outcome of the recent discussions held at Delhi?

THE MINISTER OF WATER RESOURCES (SHRI VIDYACHARAN SHUKLA): (a) and (b) It has been proposed that initially the four riversamely Meghana, Brahmaputra, Teesta and Ganga will be considered together for considering the sharing of waters between India and Bangladesh so that deficits in one can be met with from deficits in one can be met with from the quantities available in the other.

(c) In the Secretary level discussions held at Delhi in October, 1991, it was agreed that a joint observation station to monitor the flows of the Tista river would be established on the Indian side near the border. Bangladesh side gave a draft operational plan for long-term sharing of waters of the river Tista between Bangladesh and India and the Indian side presented the possibilities of formulating a comprehensive arrangement for sharing of river waters based on a long-term perspective.

Financial grant to fake colleges in Bihar

Literacy programmes in the country

*80.SHRI RAMACHANDRAN PILLAI: Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:

- (a) the details of the programmes taken up by the Central and State Governments to raise literacy in the country and the results achieved during the last three years;
- (b) the details of allocations made for each State during the last three years and the expenditure incurred thereon; and
- (c) whether Government contemplate any change in the programmes and policies and if so, the details thereof?

THE MINISTER OF HUMAN RESOURCE DEVELOPMENT (SHRI ARJUN SINGH): (a) Universalification of elementary education including the programme of non-formal education for school dropouts, and the National Literacy Mission which aims at impatting functional literacy to 80 million adult illiterates in the 15-35 age-group by 1995 form an integral part of the larger programme for eradication of illiteracy in the country. The specific results achieved under these programmes during the last three years are as under—

- (i) Undr 'Operation Blackboard' which is meant for providing the minimum essential facilities for primary schools 69% of the blocks in the country comprising of 64% of the schools have been covered so far.
- (ii) Under the Non-formal Education for children who cannot attend formal schools for various reasons, over 2.70 lakh NFE centres have so far been sanctioned for this purpose.
- (iii) 287 District Institutes of Education and training have been sanctioned so far to organise quality pre-service and in-service train-
