## Contribution towards Provident Fund by Air India and Indian Airlines

4455. SHRI RAMACHAND-RAN PILLAI: Will the Minister of CIVIL AVIATION AND TOURISM be pleased to state:

- (a) whether Government have received any proposal from the Air India and Indian Airlines requesting to allow contribution of 10 per cent monthly instead of 8.33 per cent towards provident fund contribution to their employees;
- (b) if so, whether Government have examined the proposal; and
  - (c) if not, the reasons therefor?

THE MINISTER OF CIVIL AVIATION AND TOURISM (SHRI MADHAVRAO SCINDIA): (a) to (c) Government approval has been conveyed to Air India and Indian Airlines to enhance the rate of contribution to Employees Provident Fund from 8.33 per cent to 10 per cent of pay, effective from 1st June, 1989 subject to the condition that the minimum subscription of the employees is also enhanced to 10 per cent of pay.
