## Wastelands in Gujarat

- 2554. SHRI AHMED PATEL: Will the Minister of RURAL DEVELOPMENT be pleased to state:
- (a) the status of wastelands in Gujarat with details of barren lands, lands with salinity and other types of wastelands; district-wise;
- (b) whether Government have any plans to develop these wastelands in the State by starting afforestation and other works; and
  - (c) if so, the details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF RURAL DEVELOPMENT (SHRI ANNASAHEB M.K. PATIL): (a) As per the 'Wastelands Atlas of India, 2000' the total extent of wastelands in Gujarat is 4.30 m.ha. Details of district-wise wastelands including barren land and saline land in Gujarat is given in the Annexure [See Appendix 194 Annexure No. 21]

(b) and (c) The main programmes and schemes of the Central Government for the treatment of wastelands/degraded lands having components to develop/reclaim such lands by checking land degradation and putting such lands to productive use are given in the Annexure, [see Appendix 194 Annexure No. 22]

## National Advisory Panel for "Water for All"

## Construction of Rural and Urban Housing Units in the country

- (d) whether it is true that Government have decided to constitute a GOM to address the issues concerning rural and urban housing; and
  - (e) if so, the details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF RURAL DEVELOPMENT (SHRI SUBHASH MAHARIA): (a) to (c) The State-wise number of houses constructed in the rural areas under various Rural Housing Schemes during the last three years is given in the Statement-I (See below). In so far houses constructed in the nrban areas, as per information received from the Ministry of Urban Development & Poverty Alleviation, Housing & Urban Development Corporation Limited (HUDCO) provides financial support to State government agencies for housing programme on a demand-driven basis. State-wise and year-wise performance of HUDCO financed urban dwelling units under 2 Million Housing Programme is given in the Statement-II. (See below) Targets under Rural Housing Schemes are constantly monitored, evaluated and timely action is initiated, as required, to accelerate the same to improve the implementation of the programme.
