Jars in each district has to be given to the lead bank of that district. The Lead Bank after consolidating the lists received from all banks submits it to the District Collector for recommendations and onward transmission to RBI through the concerned State Government. Under the Branch Licensing Policy (1990-^-95), opening of branches of Public Sector Banks is a continuous process and hence it is not possible to project the number of branches that will be opened in the rural areas of Tamil Nadu during the current year.

World Bank advice against soft options

THE MINISTER OF STATE IN THB MINISTRY OF **FINANCE** (SHRJ RAMESHWAR THAKUR); (a) and (b) In the 1990-91 country Economic Memorandum (prepared by the World Bank), the World Bank has observed "India no longer has soft options. Trade-offs between cutting expenditure and raising taxes and between restraining defence expenditures and solwing spending on social programs and/or infrastructural investment will require hard choices. India's pleadge to give "human face'" to adjustment and reform offers a unique challenge to donors. If India is prepared to follow through on the hard choices, the donor community should be prepared to strengthen its support significantly"^ The Country Economic Memorandum is prepared by the World Barak for facilititating consultation at Aid Iftdiat consortium saeetings_

Uniform sales tax on Commodities

THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI RAMESHWAR THAKUR); (a) Sales-tax is a State subject under the Constitution. Therefore, policy is decided by the respective States. In the Chief Ministers' Conference held in February, 1989 it was decided that the States and Union Territories would adopt the minimum floor level rates in respect Of the 29 identified items recommended by the Committee of the Sales-Tax Commissioners.

(b) There is no proopsal to expand the list of declared goods.

(b) to (d) UCO Bank has reported that 14 cases Of fraudulent payments using forged drafts totalling Rs. 21,86,809,30 and one case of withdrawl against wrong debit involving Rs. 45,000/- only were' detected in March 1990 at it, Sector 17-B Branch, Chandigarh. The Bank has further reported that in connection with these pamenyts the CBI registered a regular case on 28-11-90 against 3 Bank employees and 6 outsiders. UCO Bank has placed 4 employees under suspension.

Insurance at state expense

1055. SHRI MURLIDHAR CHAN-DRAKANT BHANDARE: SHRI BEKAL UTSAHI:

THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI DALBIR SINGH) (a) and (b) There is no such scheme run on State expenses. However victims of Hit and Run cases, against injury or death in a road accident, are compensated out of a Fund known as 'Solutium Fund' set up under the Motor Vehicles Act which is maintained and run by the General Insurance Corporation of India through its four subsidiary companies. The compensation payable in the event of death is Rs. 8,500l- and in the case of grievous hurt, it is Rs. 2,000/-,
