## Re-examining deduction of tax at source on interest

1082. SHRI PRAMOD MAHAJAN: Will the Minister of FINANCE be pleased to state:

- (a) whether Government are reconsidering the decision to tax at source the interest earned on deposits in banks;
  - (b) if so, what are the details; and
  - (c) if not, what are the reasons?

THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI RAMESHWAR THAKUR): (a) No, Sir.

- (b) Does not arise.
- (c) The deduction of tax at source from interest earned on bank deposits has been introduced as a measure of better tax compliance. This measure will help the Gov-

ernment in bringing within the tax net unaccounted and undeclared incomes which are deposited in banks.

## Release of dollars to students going abroad

#### SHRI CHATURANAN MISHRA:

Will the Minister of FINANCE be pleased to state:

- (a) whether it is a fact that Government are releasing dollars for students going abroad for studies; and
- (b) if so, the number of students who were allotted dollars and how much per student during the year 1990 and so far in 1991?

THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI RAMESHWAR THAKUR): (a) The Reserve Bank of India and selected branches of banks authorised to deal in foreign exchange are releasing foreign exchange to students going abroad for higher studies on the basis of prescribed guidelines.

(b) Details of number of students who were allotted foreign exchange and the average amount of foreign exchange per student during 1990 and 1991 (January to August) are as under:

- (a) whether some financial assistance has been received from Netherlands during current year;
- (b) if so, what are the details thereof;
- (c) whether some specific areas have been earmarked for utilising this assistance;
- (d) if so, what are the details thereof and if not, the reasons therefor;
  - (e) whether some concept of budget sup-

port assistance has also been developed with this assistance; and

(f) if so, the details thereof together with advantages of this concept?

# THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI RAMESHWAR THAKUR): (2) Yes, Sir.

- (b) In 1991-92, we have received Dfl. 91.108 million upto 31-10-91 as Dutch aid. Of this, Dfl. 35.152 million was received as loan and Dfl. 55.965 million as grants.
  - (c) Yes, Sir.
- (d) Dutch assistance is currently being utilised in the sectors of rural water supply, environment, women's development, irrigation, agriculture, non-conventional energy sources and surface transport. However, suitable proposals in other sectors can also be considered for Dutch funding.
  - (e) Yes, Sir.
- (f) The details of how to operationalise this idea are being worked out. At the conceptual stage, the perceived advantage is that Dutch aid for budget support will be given without involving the donor country in the details of project implementation.
