public are being warned in the affected areas through public address system. T.V., posters and News papers advertisement not to touch or handle any suspicious object and to report about it to the Police/ Railways Staff. Coaches of passenger trains are thoroughly checked before they are placed at the platforms. Random check of passengers luggage is also being conducted in the affected areas by police parties to identify and locate unclaimed articles.

Cleaner services in Railways

1285. SHRI SANTOSH BAGRODIA Will the Minister of RAILWAYS be pleased to state:

- (a) whether Government propose to introduce better and cleaner services in railway compartments of all classes; if so, what are the details thereof; and
- (b) whether Government also propose to issue instructions for keeping the toilets at the railway stations; completely clean for use by the general public even by charging a nominal fee?

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI MALLIKARJUN): (a) The Railway (SHRI Railway Administration accords the highest priority to clean coach evnirons. A th rough cleaning of all the coaches is ensured at Primary/Secondary Maintenance Depots. The cleaning of coaches is also attended to by Safaiwalaas at enroute stations on call basis. On certain important trains travelling Safaiwal as are also provided for cleaning the trains enroute. However, due to rush and short stoppages, sometimes a thorough enroute cleaning is not possible.

(b) Instructions already exist for keeping the station premises including toilets clean. At some stations 'PAY & USE, system has also been i n troduced.

New Railway Division in Gujarat

- (a) whether there is under Government's co any proposal consideration create new Railway Division at Ahmedabad/Gandhinagar in Gujarat;
 - (b) what is the number of proposals opening New Divisions in Western way and other Railways received by olvernment; and

(c) what is the number of them which have been accepted and what is the criteria adopted while accepting these proposals?

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHR) MALLIKARJUN): (a) No, Sir.

- (b) Since January 1990, Ministry of Railways have received proposals for the creation of 13 new railway divisional headquaters including one each at Gandhidham and Ahmedabad on Western Railway.
- (c) New Railway divisions are set-up taking into consideration the size, work-load, growth and pattern of traffic and other operational requirements of the existing divisions consistent with the needs of economy and efficiency. Except for the proposal pertaining to creation of a new divisional headquarters at Nanded which had been approved by the Ministry of Railways carlier, no other proposal for creation of a new divisional headquarters is presently under consideration of the Government.
