Satellite based regional television service to States and Union Territories

- 1425. SHRI SURESH KALMADI: Will the Minister of INFORMATION AND BROADCASTING be pleased to state:
- (a) the names of States and Union Territories in the country where the facility of satellite-based regional television service exists; and
- (b) what steps Government propose to take to extend this facility to other States and Union Territories?

THE DEPUTY MINISTER IN THE MINISTRY OF INFORMATION AND BROADCASTING (KUMARI GIRIJA VYAS): (a) Satellite derived regional television service is, at present, available in the States of Andhra Pradesh, Manarashtra, Karnataka, Orissa, Tamil Nadu and West Bengal.

(b) Regional TV Service is envisaged to be provided in other States depending upon future availability of adequate space segment, allocation of necessary funds by the Planning Commission and inter-se priorities.

Abolition of contract labour

- (a) whether it is a fact that a committee has been appointed by the Central Advisory Contract Labour Board to go into the question of abolition of Contract Labour work for loading and unloading etc. in Railways;

- (d) is answer to (b) be in negative, the reasons for delay in submitting the report?

THE DEPUTY MINISTER IN THE MINISTRY OF LABOUR (SHRI PABAN SINGH GHATOWAR); (a) Yes, Sir.

- (c) Question does not arise.
- (d) The delay had occurred because of certain changes in the composition of the Committee. However, the present Member-Convenor has been directed to finalise the report early.

Pension scheme submitted by Hota Committee
