### Recommendations of Estimates Committee regarding Fill

- 1415. SHRI VIREN J- SHAH: Will the Minister of INFORMATION AND BROADCASTING be pleased to state:
- (a) whether the Estimates Committee (1990-91) had recommended regular screening of Film and Television Institute Students' films on TV in order to fulfil the important objective of FTII in improving the technical standards of Indian television programme;
- (b) if so, what are the details of developments on this recommendation; and
- (c) what action is being taken in this regard?
- THE DEPUTY MINISTER IN THE MINISTRY OF INFORMATION AND BROADCASTING (KUMARI GIRIJA VYAS): (a) Yes, Sir.
- (b) and (c) The Governing Council of the Film and Television Institute of India in its meeting held on 27th July, 11991 recommended the telecasting of Diploma films by Doordarshan. The Institute has started the preparation of a list of suitable films to enable Doordarshan to assess their suitability for being telecast.

# Training capacity of the film and television Institute of India

- 1416. SHRI VIREN J. SHAH: Will the Minister of INFORMATION AND BROADCASTING be pleased to state:
- (a) whether it is a fact that the film and Television Institute of India (FTII), has not been able to meet the demand for training personnel in the field of television and had suggested to Government to augment the training capacity in the FTII; and
- (b) if so, the reaction of Government thereto?

- THE DEPUTY MINISTER IN THE MINISTRY OF INFORMATION AND BROADCASTING (KUMARI GIRIJA VYAS): (a) It is true that the Film & Television Institute of India has not been able to fully meet the demand for training personnel in the field of television commensurate with its phenomenal erpansion and growing demands.
- (b) The Ministry has projected a scheme costing Rs. 20.89 crores for development and expansion of the Television Wing of the Institute in the 8th Five Year Plan. The implementation of the project would depend upon availability of funds. Apart from this, there is also an approved Seventh Plan Scheme for the establishment of a Regional Staff Training Institute for All India Radio and Doordarshan at Bhubaneshwar.

#### Import of Newsprint on barter basis from Soviet Union

- 1417. SHRI KRISHNA KUMAR BIRLA: Will the Minister of INFORMATION AND BROADCASTING be pleased to state:
- (a) whether Government propose to import newsprint from the Soviet Union on a barter basis;
- (b) if so, the quantum of newsprint to be imported and at what cost;
- (c) whether the import of newsprint would ease the shortage of newsprint; and
- (d) if so, to what extent and at what price the same would be given to newspaper industry?
- THE DEPUTY MINISTER IN THE MINISTRY OF INFORMATION AND BROADCASTING (KUMARI GIRIJA VYAS): (a) Yes, Sir
- (b) 40,000 MTs; price yet to be negotiated.
  - (c) Yes, Sir.
- (d) Import of 40,000 MTs is against the supply-demand gap. The sale price

would be fixed by Newsprint Price Fixation Advisory Committee after the pur-Jiase is finalised.

# Enactment of legislation to ensure freedom and compensation to Journalists

1418. SHRI RAMDAS AGARWAL: Will the Minister of INFORMATION AND BROADCASTING be pleased to state:

- (a) whether it is a fact that recently a conference was convened in New Delhi by the IFJ, Brussels and the National Union of Journalists (NUJ) in collabora tion with the Friendrichi Ebert Foundation based in Bonn, as reported in (Hindustan Times dated 15th November, 1991 page 5 col. 2);
- (b) if so, what were the .recommendations made at the above conference and whether the Journalists demanded greater freedom to report and adequate compensation in case of injuries/deaths etc.; and
- (c) if so, what is the reaction of Government thereto and whether any lagis-lation for implementation of the recommendation to ensure freedom, is contemplated to be enacted by Government; if so, by when and if not, the reasons therefor?

THE DEPUTY MINISTER IN THE MINISTRY OF INFORMATION AND BROADCASTING (KUMARI GIRIJA VYAS): (a) Yes, Sir.

(b) and (c) Briefly stated, the Confe rence stressed the need for developing active interaction between working jour nalists of all the countries of SAARC region and the importance of security of employment and personal safety in order t<sub>0</sub> discharge their professional responsi bilities and promotion of professional The Conference inter-alia standards. impressed upon the Governments everywhere and especially in the region to treat journalists on assignments as doing public service and see that they are in no way harassed and no violence is committed against them by any agency governmental or otherwise. Besides, the Conference also urged the Governments

of the region to set up a permanent statutory body (where it does not exist) for regularly monitoring the factors that call for wage revision, for ensuring enforcement of the existing awards on wage scales and allowances and watch their service interests. The Government has noted these recommendations of the Regional Conference of Working Journalists.

सूचना और प्रसारण मंत्रालय में उप-मंत्री (कुमारो गिरिका व्यास): (क) से (घ) दूरदर्शन के हिंन्दी समाचार बुलेटिनों में मुम्बई शब्द का प्रयोग यह पता लगने के बाद रोक दिया गया कि भारत सरकार ने बम्बई शहर का नाम बदल कर मुम्बई करने का अनुमोदन नहीं किया था। दूरदर्शन द्वारा यथास्थिति तब तक बनाए रखी जाएगी जब तक भारत सरकार द्वारा शहर के नाम में किसी परिवर्तन का अधिकारिक तौर पर अनुमोदन नहीं कर दिया जाता।
