Disinvestment in Public Sector Undertakings

1404. SHRI RAMDAS AGARWAL: DR. Z. A. AHMAD: SHRI N. E. BALARAM:

Will the PRIME MINISTER be pleased to state:

- (a) whether Government have finalised the list of Public Sector Undertakings for disinvestment and if so, what criteria have been adopted while making such selection;
- (b) what is the total amount tikely to be saved as a result of disinvestment; and
- (c) whether it is proposed to disturest PSU's only in favour of financial institutions; if so, the details thereof; and what amount is likely to be given to the National Renewable Fund?

THE MINISTER OF STATE IN THE MINISTRY OF INDUSTRY (SHRI P. K. THUNGON): (a) to (c) The list of Public Sector Undertakings the shares of which are proposed to be disinvested is under consideration of the Government and shall be laid on the Table of the House when finalised.

Shifting of proposed TV Transmitter from Nagapattinam to Mayiladurai

1405. SHRI SAMAR MUKHERJEE: Will the Minister of INFORMATION AND BROADCASTING be pleased to state:

- (a) whether it is a fact that there is a move to shift the proposed TV transmitter at Nagapattinam (Tamil Nadu) to Mayiladurai in Tamil Nadu;
- (b) if so, the reasons for this sudden change; and
- (c) if not, by when the proposed transmitter would be installed at Naga-pattinam?

THE DEPUTY MINISTER IN THE MINISTRY OF INFORMATION AND BROADCASTING (KUMARI GIRIJA VYAS): (a) No, Sir. However, another low power TV transmitter has been envisaged to be installed at Mayiladukurai (Mayuram) in Thanjavur district of Tamil Nadu.

- (b) Does not arise.
- (c) The proposed low power TV transmitter at Nagapattinam is expected to be commissioned into service during the later half of 1992.

Proposal to produce a serial on the novel of Munshi Prem Chand

THE DEPUTY MINISTER IN THE MINISTRY OF INFORMATION AND BROADCASTING (KUMARI GIRIJA VYAS): (a) According to Doordarshan, no such proposal has been received by them from the said organisation under sponsorship scheme which closed on October 31, 1990.

THE DEPUTY MINISTER IN THE MINISTRY OF INFORMATION AND BROADCASTING (KUMARI GIRIJA VYAS): (a) to (d) The Inter-Departmental Committee set up by Government to suggest options available to the vernment for implementation of the scheme for offering broadcasting rights public corporations after making an indepth study of all the relevant aspects had, inter alia, met representatives of groups which had shown interest in setting up and running the new broadcasting channels to elicit their views in the matter. No formal proposals have so been invited in this regard by the Government and, as such, there is no question of acceptance or rejection of proposal.

(ग) पुरानी प्रायोजन स्कीम के अंतर्गत 19 धारावाहिक पहलें से ही अनु-मोदित और प्रमारण की प्रतीक्षा में हैं। पहले अनुमोदित और प्रसारित सभी धारा-याहिकों को फिर से प्रसारित किए जाने का कोई कार्यंक्रम नहीं है।
