THE MINISTER OF STATE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (DEPARTMENT YOUTH AFFAIRS AND SPORTS) WITH ADDITIONAL CHARGE OF MINISTER OF STATE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT PARTMENT OF WOMEN AND CHILD DEVELOPMENT) (KUMARI MAMATA BANERJEE): (a) and (b) The Government have decided to set up a National Commission for Women and also to set up a Commissioner for Women's Rights. The Commission would consist of a Chairman, 5 Members and a Member Secretary. The main functions of the Commission shall be, inter alia, to investigate and examine all matters relating to the constitutional and legal safeguards provided for women, to review the existing legislations, wherever necessary and to look into the complaints and take suo moto notice of matters relating to deprivation of the rights of women, participate and advise on the planning process of the socioeconomic development of women and evaluate the progress of the development of women. The details in regard to Commissioner for Women's Rights are being worked out.
